Insurance Dispute Mediator in Jordanian Law

ABSTRACT

This research studied insurance dispute resolution through contracting mediation under the Jordanian Law, aiming to be acquainted with the barriers blocking this method, in focusing on Insurance dispute mediator, as a prim factor in these procedures.

To achieve this goal, this study defined Insurance dispute mediator through explaining the conditions to be met and his accreditation procedures, thereafter, it specified his role in the procedures for settling such disputes through mediation, in a study conducted to analyze and evaluate the texts regulating this subject in the Jordanian law.
